## ***Continuing to Support the Harvest Work***

The DPF is not a humanitarian support organization, but was formed solely for promulgating the gospel as originally taught by Jesus Christ and distributed through the ministry and writings of Charles T. Russell.*

## ***Financial Resources***

The purpose of the Divine Plan Foundation, (a Corporation), is to preach the gospel of Christ’s Kingdom and associated teachings from the Holy Scriptures as the Lord directs and by whatever legal means available.

***To date more than \$230,000.00 have been donated and distributed to promote the Harvest Truth.*** It is not the purpose of the Foundation to solicit funds for it work, and we are not here doing that. We are however making known to all those that have a willing heart, those in agreement with the purpose of the Foundation and it work of the Foundation, and so desire to participate, that the Divine Plan Foundation is non-profit organization to which funds can be donated.

## ***On Estate Planning---***

The Foundation is recognized by the IRS as a non-profit organization and can provide brethren with appropriate documentation for donations. We do not solicit donations, but can receive them. We merely suggest that due diligence should proactively offset unnecessary problems if preparations are done in a

timely manner. As Bible Students, trust in God and know that He will handle and overrule in all of life's affairs. We are admonished to see that our families are provided the things need. (Romans 12:17 – "provide things honest in the sight of all men."

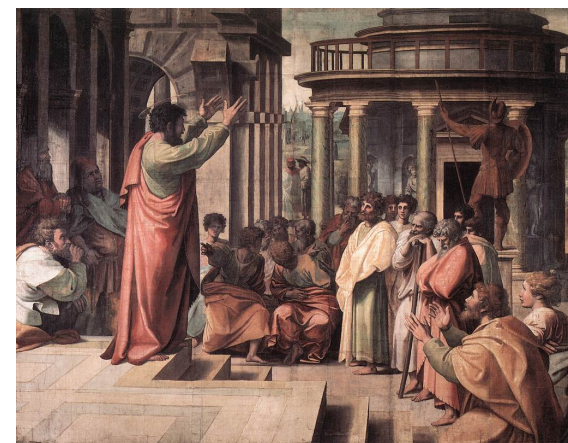
